- Staff that cover the awake overnight shift are required to call in every 2 hours at 11pm, 1am, 3am, 5am, and 7am and to complete the iManage documentation for individuals documenting whether each is asleep or awake at 12am, 2am, 4am, 6am. If the computer goes down, call your coordinator and make hourly calls.
- If an individual is awake, a notation of what is happening should be entered into the comments.
- All staff who cover this shift need to follow the policy to ensure all are maintaining the health and safety for the individuals.
- This documentation justifies to the State why the position is important. Without such, the State can question the position and deny funding to cover it.
- **COMPLETING THE DOCUMENTATION AND CALL IN SAVES YOUR JOB POSITION** and it ensures that all know each individual is safe and being taken care of by good staff.



When giving out medications, don't forget to do a three way check! Individuals depend on you and it is a health and safety matter!
